To All Payroll Departments:

Effective **October 3, 2011**, the Cement Finishers have increased their Vacation Fund deduction, from **\$2.31** per hour to **\$2.61** per hour. This increase will **not** affect the Base Rate or any other benefits paid. The working dues, paid out of the Vacation Fund, have increased **\$0.30** per hour, from **\$1.85** to **\$2.15** per hour. The Base Rate remained the same, **\$32.57** per hour.

Effective **October 3, 2011** through **May 31, 2012**

Foreman shall be paid 10% over Journeyman base rate.

The base rate before the deduction of Vacation Fund is the straight time wage used in determining overtime. (Example: 1.5 x \$32.57 = \$48.86 taxed, then minus \$2.61 for Vacation each hour). After all taxes are deducted from the base rate, \$2.61 per hour for each hour worked shall be deducted and sent to the Vacation Fund office.

**** PLEASE DO NOT DEDUCT WORKING DUES FOR AREA 558 MEMBERS.**

Only the Vacation Fund contribution (\$2.61) should be deducted from base rate after taxes for area 558 members. (The Fund will deduct our working dues from the vacation money)

*** For members of any other area Local Union, working dues (\$2.15) are deducted from base rate after taxes.**

Total package wage rates shall increase effective: May 31, 2012, to be determined.
